

Instructions for Authors

AIMS AND SCOPE

The International Journal of Developmental Biology (ISSN: 0214-6282) is an independent, not for profit scholarly journal, published by scientists, for scientists. The journal publishes papers which throw light on our understanding of animal and plant developmental mechanisms in health and disease and, in particular, research which elucidates the developmental principles underlying stem cell properties and cancer. Technical, historical or theoretical approaches also fall within the scope of the journal. **Criteria for acceptance** include scientific excellence, novelty and quality of presentation of data and illustrations. **Advantages of publishing in the journal** include: rapid publication; free unlimited color reproduction; no page charges; free publication of online supplementary material; free publication of audio files (MP3 type); one-to-one personalized attention at all stages during the editorial process. An easy online submission facility and an open online access option, by means of which papers can be published without any access restrictions. In keeping with its mission, the journal offers free online subscriptions to academic institutions in developing countries.

ARTICLE TYPES

Original Article: Abstract, Introduction, Results, Discussion, Materials & Methods, Acknowledgements, References, Tables and Figure Legends (max. 8,000 words including figure legends and 30 bibliographic references).

Review: Abstract, Text, Acknowledgements, References, Tables and Figure Legends (max. 10,000 words including figure legends and 50 references).

Short Communication: Same format as Original Article, but presenting preliminary results with potentially outstanding relevance. Should not exceed 4 journal pages (approx. 800 words per page including illustrations and references).

Developmental Expression Pattern: Must present concise descriptions of relevant genes or proteins and discuss their potential relevance for the interpretation of the mechanisms of development. DNA and amino acid sequences and corresponding accession numbers should be provided (max. 4,000 words including figure legends and 20 references).

Technical Article: Abstract, Introduction, Experimental Protocols, Results & Discussion, Acknowledgements, References, Tables and Figure Legends (max. 5,000 words including figure legends and 20 bibliographic references).

Essay, Special Contribution, Developmental Perspective or Meeting Report: There are no structural restrictions, but an Abstract must be provided. Essays typically include theoretical considerations, whereas Special Contributions are devoted, for instance, to the update of tables

of development of different organisms.

Interview: Introduction (biographical sketch and relevance of the personality of the interviewee in Developmental Biology), Questions and Answers, Acknowledgements and References and/or Selected Bibliography (max. 8,000 words including figure legends).

MANUSCRIPT PREPARATION

1. Cover letter to the Editor

- Should be sent as a separate document.
- Should include an **ethical statement** that the manuscript has not been, nor will be, simultaneously submitted to other journals while under review at the *Int. J. Dev. Biol.*
- If more than one corresponding author, please specify the author to whom the corresponding invoice (if any) should be sent.
- Your paper will be handled by the Editor-in-Chief, unless you specify an Associate Editor from your geographic area whom you would prefer to manage the peer review of your paper.

2. Text and Illustrations

- **Title page:** specifying the title of the paper, names of authors (including full first names), abbreviated institutional affiliations, running title (not more than 50 characters), key words (max. 5), DDBJ/EMBL/GenBank or Pathbase accession numbers (if applicable) and the contact details (postal address, telephone and fax numbers, e-mail, Web URL) of the corresponding author.
- **The e-mail addresses** of all authors.
- **Abstract:** Must be structured to contain the following sections: Background, Methods, Results, Conclusion. Maximum of 250 words.
- **Text of manuscript:** must be written in clear, concise English. Non-English speaking authors should have their papers revised by a native English speaking scientist. Manuscripts should be checked with your software "Spelling" function, to detect typographical errors, before submitting to the Editorial Office. Avoid complex formatting as this will be done by our designers
- **References Section:** The indications of the Submission Manuscript Checklist document must be followed.
- **Illustrations.** Should be of sufficient quality for the referee to appreciate the relevant details. Please use color (free of charge) to enhance visual quality.

- 3. Electronic Supplementary Material** (if appropriate): videos, pod casts, long nucleotide or peptide sequences and other complementary material can be considered for electronic publishing on the Web of the journal. The format and application used to view the material should be specified.

SUBMISSION OF MANUSCRIPTS

Please prepare your manuscript **as a single PDF document** (< 16 Mb) including text, tables and illustrations. Later, if your manuscript is definitively accepted for publication, specific file formats for text, illustrations, etc. will be requested by the Editorial Office.

- The simple procedure involves copy and pasting the contents of the Title Page of your manuscript and uploading the corresponding files.
- It is not necessary to send big, highest quality image files for your initial submission. Images which you consider to be of **sufficient quality in PDF format** are usually acceptable for peer review. Highest quality images are only required once a paper is finally accepted for publication.
- Candidate referees should be competent to independently evaluate your work. They should preferably be cited in the References. You should not have co-authored papers with them in the last 5 years.
- Manuscripts must be carefully formatted in accordance with our **Manuscript Submission Checklist**.

PAPERS ACCEPTED FOR PUBLICATION, PROOFS AND REPRINTS

Journal Cover Authors are encouraged to submit illustrations, together with a corresponding legend, as candidates for the Journal Cover. The illustration does not necessarily have to be directly from the author's paper but must be related to the subject matter. Cover illustrations will be chosen on the basis of their scientific content, esthetic quality and resolution. The author who submits the definitive cover illustration will receive his/her reprints bound with the cover picture at no extra cost.

Compliance with Funding Agencies' Archiving Conditions Payment of the Open Access fee covers deposition of accepted papers on behalf

of author in the corresponding repository (PubMed Central, etc.) without any embargo. The author must specify the Funding Agency, Grant Number and corresponding repository. If the Open Access option has not been selected by authors, they are granted permission to self archive the final published manuscript in their academic repository or deposit in any repository six months after publication.

Open Access and Fast Track options

- If you wish or your funding agency (NIH, NIMR, Wellcome Trust, etc) requires you to publish your paper **Open Access**, please let us know (Cost 1500 Euro), so that we can prepare your paper accordingly.
- Please note that authors from **subscribing institutes can claim a 25% discount** on digital and paper publishing products/services. If your library is not subscribed to the *Int. J. Dev. Biol.*, you can still avail of this offer if your librarian returns to us the Trial Online Access form, also available in the "Documents" section of your "vitJournals" profile.
- Proof elaboration can take around 8-10 weeks. However, if you need the definitive proofs urgently (within a week or so) and your paper published online rapidly, you can choose our **Fast-Track Processing** option. If you wish to contract this option, simply let us know by e-mail.

Press Releases Authors are invited to accompany the revised version of their paper with a short (250 word) paragraph, written for the general public, in which the objectives of the study and the significance of the results are presented. This can also be optionally presented as an audio file (MP3 or similar) for publishing with the online abstract of your paper.

Reprints can be ordered in the form of a "Reprint Package" (including options to purchase copies of the journal, Open Online Access etc.) when corrected proofs are returned to the IJDB Editorial Office.

Rejection Policy Peer-review has occasionally been reported to be susceptible to personal bias and subjectivity. If you feel your paper has been unfairly rejected, please do consider appealing the decision, by concisely stating why you think the evaluation of your paper has been unfair. When such appeals are accompanied by sufficient evidence, the Editor-in-Chief may seek further evaluations of your work.
